# Declaration of Intent for Motu Ma'au

## By the Sovereign Authority of

## The Grayt Walk Of Life Tribal Trust

We, the sovereign people of **The Grayt Walk Of Life Tribe** (TGN-The Grayt Nation), acting in alignment with divine will, our sacred bond with the Creator, and the constitutional authority granted to us by **The Grayt Walk Of Life Tribal Constitution** (TGN-The Grayt Nation), do hereby declare our **spiritual intent** for the land known as **Motu Ma'au**, located in French Polynesia, as a **sacred space** for the collective well-being and divine guidance of our people and future generations.

### Sacred Purpose and Divine Sovereignty

We acknowledge and affirm that this land is **gifted to us by the Creator** as a **spiritual sanctuary**, where our people can reconnect with the divine source of all creation. We honor the inherent sacredness of this land and recognize it as part of the collective inheritance of **The Grayt Walk Of Life Tribe** (TGN).

Through this declaration, we set forth our **divine intention** to utilize **Motu Ma'au** for the following purposes:

1. **A Spiritual Sanctuary for Healing and Connection**

This land shall serve as a **sacred refuge** where members of TGN may come together in communion with the Creator, engage in **spiritual reflection**, and experience the peace, clarity, and guidance that is essential to the fulfillment of their divine purpose.

2. **A Tribal and Leadership Sanctuary for Visionary Guidance**

We shall establish this land as a **sanctuary of leadership**, where spiritual and tribal leaders will convene in council to receive divine guidance, strategize the advancement of our collective mission, and serve the greater good of the Tribe with integrity, wisdom, and vision.

3. **Cultural Preservation and Stewardship**

We declare our intent to **preserve** the **sacred teachings** of our ancestors on this land. It shall be a place of cultural immersion, education, and growth, where the wisdom of the past is passed down to the future in harmony with divine law.

## Intent to Steward and Acquire

While we do not yet hold legal title to this land, we assert our **spiritual and sovereign authority**, under the framework of our **Grayt Walk Of Life Tribal Constitution**, over **Motu Ma'au** in alignment with the sacred principles established in our **Tribal Trust Charter**. We intend to acquire this land through lawful means, with the guidance of the Creator and the support of those who align with our mission. The **Grayt Walk Of Life Tribal Trust** shall be the entity through which this acquisition is made, ensuring that this land is protected and stewarded in accordance with our sacred purpose.

We affirm our **right to govern** this land and to treat it as **sacred stewardship**, guided by divine wisdom and the collective will of the Tribe. We recognize that the land is not merely a physical asset but a **spiritual inheritance** that will be cared for in perpetuity, ensuring that it serves as a **source of empowerment and guidance** for generations to come.

## Declaration of Constitutional Authority

By the authority of the **Grayt Walk Of Life Tribal Constitution**, and in accordance with the spiritual and natural laws that govern us, we declare that **Motu Ma'au** is a **sovereign space**, bound by the sacred laws of our people and the divine. Its purpose transcends the material, holding a place of **spiritual significance** that will foster the collective growth of our people.

We assert that our sovereignty over this land is derived solely from the **Creator** and the **divine guidance** that flows through us, as articulated in our **Constitution**, which affirms our inherent **right to govern, control our lands**, and uphold the sacred **values** of our Tribe. We do not seek external validation, yet we recognize the universal principles that affirm our rights as a sovereign people. We claim this land as part of our **spiritual legacy**, to be honored and upheld in alignment with divine law.

## Vision for the Future

This declaration is the first step in the **manifestation of our vision** for **Motu Ma'au**. As we prepare for the **legal acquisition** of the property, we commit ourselves to ensuring that it remains a **sanctuary of peace, leadership, and spiritual fulfillment**. We will protect and nurture this land, using it as a space to:

- **Enhance our cultural practices**
- **Foster community leadership**
- **Empower our people spiritually and materially**
- **Share our teachings with the world**

We recognize the sacredness of this land and its **divine purpose** in our spiritual journey as a Tribe. We commit to **honoring its sanctity** and using it as a force for good, both for the Tribe and for the broader community.

## Final Proclamation

In the name of **The Grayt Walk Of Life Tribe**, and by the sacred authority granted to us by **The Grayt Walk Of Life Tribal Constitution**, we declare our **intent** to bring the land of **Motu Ma'au** under the stewardship of our Tribe, fulfilling the divine vision that has been placed before us.

This declaration affirms that **Motu Ma'au** will stand as a **symbol of spiritual and sovereign leadership**, an eternal testament to the divine guidance that leads our people to fulfill their highest purpose.
